<u>COURSE OBJECTIVES</u>: This course examines topics in occupational biomechanics and applied ergonomics. This course will lay the groundwork necessary to become a consulting occupational biomechanist. Upon completion of this course, the student will have developed:

- An appreciation of the role of biomechanics in occupational health and safety issues.
- The knowledge to identify specific tissues at risk
- Qualitative and quantitative skills to assess the risk of injury associated with workplace layout, tasks, and tools.
- The ability to redesign operations to reduce the risk of injury.
