Time and Location:

Times: 3 hours per week at an assigned clinic placement. Placement maybe on or off campus.

Expanded Course Description:

This experiential education course is designed for students who are in their first year in the Athletic Therapy Certificate program. Students will be assigned to the Gorman Shore Sport Injury Clinic or another designated post-secondary placement for three hours per week for the full year.

Students will be involved in a hands-on experience involving basic health care record management, clinical assessments and basic treatment provision. They will work under the direction of Certified Athletic Therapists to gain clinical experiences.

Organization of the Course:

This course includes students being assigned to a clinical placement by the course instructor. Students will be required to establish clinical goals using a learning contract template as well as complete assignments related to introductory clinical practice throughout the year. Students will be exposed to, and have the opportunity to conduct basic assessments and treatments under supervision.

Course Learning Outcomes:

Through the opportunities provided by this course, first year Athletic Therapy students will have demonstrated the ability to:

Actively participate in the basic operations of a working, health care facility. Practice basic orthopaedic assessment techniques for injuries of the upper and lower extremities under the guidance of Certified Athletic Therapists. Provide basic orthopaedic treatments for injuries of the upper and lower extremities to athletes/clients of the clinic under the guidance of Certified Athletic Therapists. Identify basic elements of rehabilitation design under the guidance of Certified Athletic Therapists.

Recognize the health care document government guidelines for privacy.
